CCS is located in the heart of Detroit MI. There is a grade 6-12 charter school, UPAD, on our campus serving a low-income urban demographic that provides experience for our pre-service teachers. CCS Art Education students complete a minimum of 15 field hours at the charter school on our campus. In addition, we often place our students in one of the local urban schools for half of their student teaching experience, and then place them in a rural or suburban setting for the second half. Additionally, CCS Art Education students continue complete 10 hours of field experience at a facility, through Friendship Circle and Soul Studio, for children and young adults with special needs during their course of study. Also of note, the Community Arts Partnership (CAP) program at CCS provides an opportunity to complete a minimum of 20 hours toward the service learning project requirement which affords them opportunities to work with diverse populations in a variety of community settings outside of the traditional classroom. Finally through

CE (Continuing Education), many of our students participate as teaching assistants, providing instruction during the summer programs and support of instructions for diverse learners in the Detroit region. During student teaching, students are placed in settings where ELL students are enrolled and also mentored in IEP protocols as appropriate.

CCS Art Education Students use interactive white boards, Elmo's, computers, and iPads to teach lessons and involve students in hands-on learning. In addition students employ web based applications such as Jamboard, padlet, miro, and mind mapping softwares to promote collaboration in teaching and learning. Additionally, the use of technology for assessment is employed as students photograph and reflect on learning process and progress which makes visual, learning and growth. More recently, we are exploring the integration and ethical uses of AI. Finally, students are fluent in the use of LMS's from a students perspective and the impacts of well designed LMS courses as a teaching and assessment tool in the event they will need to use an LMS as they enter the profession. As art & design majors, our students use Wacom tablets to teach drawing, incorporate animation and video design in lessons, use computers and tablets to teach graphic and product design projects. Most students are fluent in the Adobe suite. In addition, CCS art education students design lessons and units specifically to address online and remote learning needs as well as incorporating the use of the internet for research. Further, Art education and College for Creative studies have developed polices are the responsible use of AI both as a teaching and learning tool as well as a pedagogical support. AI as a research an ideation tool while also providing transparency and approbate citing of the use of AI is becoming integrated into the program CCS is a college for art and design. Design Thinking is embedded in all they do in their foundations and studio courses. The Art Education Department requires students to apply their knowledge of Design Thinking to the principles of universal design learning in the art education methods classes.

CCS art education students complete this in conjunction with the Human Development course. This course is specifically designed to address a spectrum of students with special needs including seen and unseen disabilities. Actions in this course include the design and implementation of a lesson during a field experience which can address a full spectrum of needs which guarantees success for all learners. CCS has partnerships with various community centers and schools that provide educational experiences for CCS Art Education students with special needs populations. This includes Friendship Circle, and Soul Studio in Bloomfield Hills, as CCS art education students visit and participate in activities in order to gain real life experience which they then apply to their curriculum and lesson plan design. Additionally, in all art education courses, issues of accommodations and modifications are addressed when considering lesson planning and implementation.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

CCS art education students are exposed to this first in conjunction with the Human Development course. All art education students complete a minimum of 10 hours of field experience teaching students identified with severe physical and cognitive impairments (special needs) at, Friendship Circle and/or Soul Studio. Our students have the opportunity to observe students in a life skills setting in order to better understand the needs as well as strengths of special needs learners. They participate in conversations with the educators present at these facilities to become aquatinted with the processes and procedures for working with special needs students. In addition, we are cultivating new relationships in school districts which serve different populations of special needs students. During the student teaching we explicitly address IEP process and procedures so students have the opportunity to experience this while in the student teaching setting. We are also address this topic in the seminar course which accompanies the student teaching experience.
